DWI Planning Council Minutes September 7, 2017

- I. **Call to Order:** by Sgt. Chris LoCoco at approximately 2:05 p.m.
- II. **Introduction of Board Members:** Members present were: Sgt. LoCoco, Misty Curry-Hernandez (proxy), Holly Mata, Bill Garza, Lt. Leonardo Ornelas, Eloise Damon (proxy) and Maureen Schmittle.
- III. **Introduction of DWI Staff:** Present were Paige Viscarra, Mary Carter, Cambri Johnson, Gaby Viscarra, Mary Carter, Daniel Caywood and Rhonda Schuh.
- IV. **Determination of Quorum:** Quorum was determined by Rhonda Schuh.
- V. **Old Business:** May 4, 2017 minutes were reviewed and approved.
- VI. **New Business:**
 - A. Paige and Cambri went over the Stats for April through June 2017.
 - a. April - June DWI Stats:
Number of DWI offenders NEEDS Survey's entered in the ADE Data Base: 44; from Magistrate Court: 28; from District and/or Municipal Court: 16. Number of new DWI Clients: 39. The Average BAC was 0.14. Number of DWI cases through the court is 85. Number of DWI offenders currently being tracked (Active and Pending): 224; Number of clients that were closed successfully: 30; unsuccessfully: 8; Deceased: 1; Number of Probation Violations issued by DWI Staff: 17; Number of Screenings/Pre Sentence Screenings (drug/alcohol): 31.
 - b. April - June Teen Court Stats:
Number of MIP (Minor in Possession) Alcohol: 2; Marijuana: 13; Number of Juvenile Traffic charges/cases 23/20; Number of Juvenile Criminal charges/cases: 39/29; Number of current Teen Court Offenders: 58; Number of Teen Court Community Service Hours served: 1509; Number of Teen Court Completions: 20; Number of Teens referred back to referral agency: 4; Number of Teen Court outreach prevention activities hosted: 3.
 - c. April - June Prevention Stats:
Number of Community outreach prevention activities hosted by DWI Staff: 4; Number of school based DWI/Substance Abuse prevention activities: 2; Number of schools which

prevention activities occurred: 2; Number of students who attended prevention activities: 65; Number of adults attending prevention activities; 5.

- B. Cambri discussed finding updated classes and curriculum for teen court. She also mentioned that they are hoping to find alternatives to long term suspensions or expulsions. And looking into whether or not the School Resource Officers will be able to recommend students to Teen Court.
- C. The motion to raise the cost of the NEEDS survey from \$32.00 to \$40.00 was made. It was seconded and passed.
- D. The next VIP (Victim Impact Panel) will be September 7, 2017. There will not be another until December.
- E. Cambri went over the results of the JAF grant monies requested. She requested \$25,000 and \$20,000 was approved.
