Adjusting Precinct Boundaries

WHEREAS, pursuant to Subsection A of NMSA 1978, Section 1-3-5 (2019), it is the duty of the Board of County Commissioners by resolution to create, divide, abolish, combine or adjust the boundaries of any precincts as necessary to meet the requirements of the Election Code as well as the legal and constitutional requirements for redistricting; *and*

WHEREAS, pursuant to Subsection C of NMSA 1978, Section 1-3-12 (2019), in the year prior to a federal decennial census, changes to precinct boundaries shall be upon the recommendation of the County Clerk; *and*

WHEREAS, it has been determined by the County Clerk that precinct boundaries should be created, divided, abolished, combined or otherwise adjusted as provided in the boundaries attached to this Resolution.

WHEREAS, it has been determined by the County Clerk that Precincts 1,8,15,18,24,35,49 and 52 within Otero County should be adjusted and established as full precincts for all future elections;

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners the precincts in the County shall conform to the adjustments and designations as shown on the attached precinct boundaries; *and*

BE IT FURTHER RESOLVED, that pursuant to NMSA 1978, Section 1-3-8 (1975), upon adoption of this Resolution, the Board of County Commissioners shall send a certified copy of this Resolution to the Secretary of State and to the County Chairman of each of the major political parties and shall publish once the resolution in a newspaper as provided in NMSA 1978, Section 1-1-14 (2011).

PRECINCT 1 – CHAPARRAL FAR SOUTH FIRE STATION, CHAPARRAL, NM

Beginning at the point where the southern Otero County - Texas state line intersects US Hwy 54, thence West along the southern boundary of Otero County along State Line Road to Angelina Boulevard, thence North along Angelina Boulevard to Steve Drive, thence East along Steve Drive to Salome Drive, thence North to Angelina Boulevard, thence East along Angelina Boulevard to US Hwy 54, thence Southwest along US Hwy 54 to Angelina Boulevard, thence West along Angelina Boulevard to the point of beginning.

Beginning at a point where Karr Canyon Road and Sunspot Highway intersect, thence North along Sunspot Highway 2.7mi to a 4WD trail, thence Northwest 0.8mi along the 4WD trail to an unnamed stream, thence North 1.1mi along an unnamed stream to an unnamed stream, thence East along the unnamed stream to the Cloudcroft Municipal School District line, thence North along the Cloudcroft Municipal School District line to US Hwy 82, thence North along US Hwy 82 to Bailey Canyon Road, thence North and East along Bailey Canyon Road to La Luz Canyon Road, thence North along La Luz Canyon Road to a 4WD trail, thence Northeasterly along the 4WD trail to the southern boundary line of the Mescalero Apache Reservation line, thence West (1.7mi) along the Mescalero Apache Reservation Line to a point on the Mescalero Apache Indian Reservation in Section 14, T15S, R12E, at the Apache Canyon ridge line, thence South on the Apache Canyon ridge line to La Luz Canyon Road, thence Southwesterly along La Luz Canyon Road to Calico Peak Road, thence Southwesterly along Calico Peak Road to the Salado Canyon arroyo, thence Southwesterly along the Salado Canyon arroyo to the Fresnal Canyon arroyo, thence East along Fresnal Canyon arroyo to Fresnal Canyon Road, thence Westerly along Fresnal Canyon Road to Steep Hill Road, thence Southeasterly along Steep Hill Rd to US Hwy 82, thence West 0.6mi along US Hwy 82 to Dry Canyon road, thence 0.1mi South on Dry Canyon Road to the Horse Ridge jeep trail, thence Southerly 2.2mi along the Jeep Trail to its endpoint on Horse Ridge in Section 11, T16S, R10E, thence South 3.9mi along the Horse Ridge ridgeline to Dry Canyon Road thence East along Dry Canyon Road to West Side Road, thence Northeasterly to an unnamed arroyo in Section 20, T16S, R11E, thence South 0.9mi along the unnamed arroyo to a ridgeline, thence North 0.1mi along the ridgeline to an unnamed arroyo, thence Northeasterly along the unnamed arroyo to the Karr Canyon Creek, thence South along Karr Canyon creek to Karr Canyon Road, thence South and East along Karr Canyon Road to the point of origin.

PRECINCT 10 – BURRO FLATS FIRE STATION, LA LUZ, NM

Beginning at the intersection of La Luz Canyon Road and Calico Peak Road, thence East 3.0mi along a Luz Canyon Road to an unnamed ridge line, thence North along the unnamed ridge line to the South boundary of the Mescalero Apache Reservation, thence West and North along Mescalero Apache Reservation boundary to the Labrocita Canyon arroyo, thence Southwest along the Labrocita Canyon to a ridgeline point in Section 13, T15S, R10E, thence Southeast on the ridgeline to an unnamed arroyo, thence Southerly 0.3mi on the unnamed arroyo to the Cottonwood Wash, thence East 0.4mi along the Cottonwood Wash to an unnamed arroyo, thence Southeasterly 0.7mi along the unnamed arroyo to a ridgeline, thence Southerly 0.2mi along the ridgeline to an unnamed arroyo, thence Southwesterly along the unnamed arroyo to the La Luz Creek, thence West along the La Luz Creek 0.1mi to an unnamed arroyo, thence South along the unnamed arroyo to the Mill Ridge, thence South along Mill Ridge to Forest Road 5575, thence Southwesterly along Forest Road 5575 to U.S. Highway 82, thence East along U.S. Highway 82 to Steep Hill Road, thence Northwesterly along Steep Hill Road to Fresnal Canyon Road, thence East along Fresnal Canyon Road to the Fresnal Canyon arroyo, thence Northwest along the Fresnal Canyon arroyo to the Salado Canyon arroyo, thence Northeast along the Salado Canyon arroyo to Calico Peak Road, thence Northeast along Calico Peak Road to the point of beginning.

PRECINCT 11 – MESCALERO COMMUNITY CENTER, MESCALERO, NM

Beginning at the intersection of Lower Elk Canyon Road and Indian Service Road 54, thence Northwesterly along Lower Elk Canyon Road to NM Hwy 244, thence Northwesterly along NM Hwy 244 to Indian Service Road 16, thence West along Indian Service Road 16 to San Juan Drive, thence North along San Juan Drive to NM Hwy 244, thence North along NM Hwy 244 to US Hwy 70, thence South along US Hwy 70 to White Mountain Drive, thence North along White Mountain Drive to Indian Service Road 11, thence West 5.6mi along Indian Service Road 11 to an unnamed road, thence West 0.2mi along the unnamed road to the Mescalero Apache Reservation boundary, thence South and East to Indian Service Road 54, thence Northeasterly along Indian Service Road 54 to the point of beginning.

PRECINCT 12 – TULAROSA COMMUNITY CENTER, TULAROSA, NM

Beginning at a point on the West boundary line of the Mescalero Apache Indian Reservation at Labrocita Canyon Road, thence South along Labrocita Canyon Road to Forest Road 329B, thence Northerly along Forest Road 329B to Virden Road, thence North and West along Virden Road to U.S. Highway 70, thence Northeasterly 1.8mi to an unnamed road, thence Westerly along the unnamed road to the Tularosa Creek, thence Southwest along the meandering Tularosa Creek to N Bookout Road, thence South and West along N Bookout Road to U.S. Highway 54/70, thence South along U.S. Highway 54/70 to Laborcita Arroyo, thence Easterly along Laborcita Arroyo to the West boundary of the Mescalero Apache Reservation, thence North along the West boundary line of the Mescalero Apache Reservation to point of beginning.

PRECINCT 13 – TULAROSA INTERMEIATE SCHOOL, TULAROSA, NM

Beginning at a point where the Otero County Line meets the west boundary of the Mescalero Apache Reservation, thence South and East on the west boundary of the Mescalero Apache Reservation to Rinconada Creek, thence Southwesterly 1.0mi along Rinconada Creek to an unnamed arroyo, thence South 60ft along the unnamed arroyo to Coyote Canyon Road, thence Southwesterly 3.6mi along Coyote Canyon Road to an unnamed road, thence Northeasterly 430ft along the unnamed road to a powerline, thence Southwest along the powerline to the Tularosa Creek, thence Westerly along the meandering of the Tularosa Creek to N Bookout Road, thence South and West on N Bookout Road to U.S. Highway 54/70, thence North along U.S. Highway 54/70 to the Otero - Lincoln County line, thence East along County line to the west boundary of the Mescalero Apache Reservation, thence South and East along the west boundary of the Mescalero Apache Reservation to point of beginning.

PRECINCT 14 – TULAROSA PUBLIC SAFETY FACILITY, TULAROSA, NM

Beginning on the Otero - Lincoln County line and U.S. Highway 54, thence South along U.S. Highway 54 to Rosario Lane, thence West on Rosario Lane to Calle del Flor, thence South and West along Calle del Flor to 7th Street, thence Northwesterly along 7th Street to Higuera Avenue, thence West along Higuera Avenue to the Union Pacific Railway, thence North along the Union Pacific Railway to the Tularosa Creek, thence West on the Tularosa Creek to the WSMR P Route 9, thence South along the WSMR P Route 9 to WSMR P Route 6, thence West along WSMR P Route 6 to the Otero-Lincoln County line, thence North and East along the Otero-Lincoln county line to the beginning.

PRECINCT 15 – DUNGAN FIRE STATION, ALAMOGORDO, NM

Beginning at a point on the South line of the Mescalero Apache Indian Reservation at a point where State Highway 244 intersects said line, thence Southwest along State Highway 244 to Dry Canyon Road, thence South along Dry Canyon Road to Water Tank Rd, thence West 0.3mi to an unnamed arroyo, thence South 0.3mi along the unnamed arroyo to Forest Road 9208B, thence North and South along Forest Road 9208B to Forest Road 5586, thence Westerly along Forest Road 5586 to US Hwy 82, thence West along US Hwy 82, thence West along US Hwy 82 to Pumphouse Canyon Road, thence Southeasterly 2.8mi to a ridgeline, thence Southeasterly 2.2mi along the unnamed ridgeline to an unnamed arroyo, thence South along the unnamed arroyo to a ridgeline in Section 11, T16S, thence South .6mi along the ridgeline to a ridgeline, thence Southeasterly and East 5.4mi along the ridgeline to an unnamed road, thence Northeasterly to Curtis Canyon Road, thence Northerly along Curtis Canyon Road to Eightmile Canyon Road, thence Northeast along Eightmile Canyon Road to U.S. Highway 82, thence East along U.S. Highway 82 to Three Mile Canyon Road, thence Northerly along Three Mile Canyon Road to County Road C011 (Walker Canyon Road), thence Northerly along County Road C011 (Walker Canyon Road) to County Road C009 (16 Springs Canyon Road), thence Westerly on County Road C009 (16 Springs Canyon Road) to Baird Canyon Road, thence Northwesterly along Baird Canyon

Road to the South line of the Mescalero Apache Reservation South boundary line, thence West along said line to point of beginning.

Beginning at a point on the Curtis Canyon Road in Section 28, T16S, R13E, thence Easterly along Curtis Canyon Road to Rio Peñasco Road, thence South and West along Rio Peñasco Road to NM Hwy 24, thence South along NM Hwy 24 to Bear Canyon Road, thence West along Bear Canyon Road to an unnamed stream in Section 10, T17S, R13E, thence West 1.1mi along the unnamed stream to a ridgeline, thence Northeasterly .4mi along the ridgeline to an unnamed arroyo, thence West .5mi along the unnamed arroyo to Prestridge Hill Road, thence Southerly 3.2mi along Prestridge Hill Road to an unnamed arroyo, thence North 1.1mi along unnamed arroyo to the Prestridge Hill ridgeline, thence Westerly 1.5mi along Prestridge Hill ridgeline to an unnamed arroyo in Section 19, T17S, R13E, thence Northeasterly 1.7mi along the unnamed arroyo to Wills Canyon stream, thence Westerly .9mi along Wills Canyon stream to an unnamed arroyo, thence West 1.9mi along the unnamed arroyo to ridgeline in Section 13, T17S, R12E, thence Easterly 1mi along the ridgeline to an unnamed arroyo, thence North 1.6mi along the unnamed arroyo to the Rio Peñasco, thence East 0.15mi along the Rio Peñasco to an unnamed arroyo, thence Northerly along the unnamed arroyo to a ridgeline at Section 1, T17S, R 12E, thence West 0.3mi along the ridgeline to an unnamed stream, thence North along the unnamed stream to the Wilmeth Canyon stream, thence Northeasterly along the Wilmeth Canyon stream to the Dark Canyon Stream, thence East 0.2mi along the Dark Canyon stream to an unnamed arroyo, thence North .3mi to a ridgeline, thence Northwesterly 0.6mi to an unnamed arroyo, thence North along the unnamed arroyo to the Cox Canyon stream, thence West 0.1mi to an unnamed arroyo, thence north along the unnamed arroyo to an unnamed ridgeline, thence Easterly 3.2mi to an unnamed road, thence Northeasterly to Curtis Canyon Road and point of beginning. In accordance with Section 1-3-7.1 NMSA 1978, this precinct shall have three polling places:

to County Road A011 (Star War Road), thence East along County Road A011 (Star War Road) to U.S. Highway 54, thence North along U.S. Highway 54 13.8mi to Dulce Drive, thence West 150ft along Dulce Drive to a local road, thence West along the local road to a powerline, thence West along the powerline to 1st Street, thence Westerly along 1st Street to U.S. Highway 70, thence West along U.S. Highway 70 to boundary line between Otero and Dona Ana Counties, thence South along boundary line to point of beginning.

PRECINCT 61 – NATIONAL GUARD ARMORY, ALAMOGORDO, NM

Beginning at the Intersection of Desert Lakes Road and the Union Pacific Railway, thence North 0.25mi along the Union Pacific Railway to an unnamed arroyo, thence East along the unnamed arroyo to S. Florida Ave, thence South along S. Florida Ave to Desert Lakes Road, thence West along Desert Lakes Rd. and the point of beginning.

PRECINCT 62 – NATIONAL GUARD ARMORY ALAMOGORDO, NM

Beginning at the intersection of Ocotillo Drive and S Florida Avenue, thence East along Ocotillo Drive to Alamo Canyon Road, thence Southeast along Alamo Canyon Road to the Alamo Canyon Arroyo, thence West along the Alamo Canyon arroyo to Canyon Road, thence North along Canyon Road to the North Fork of Alamo Canyon Arroyo, thence West along the North Fork of Alamo Canyon Arroyo to the Alamogordo Municipal line, thence South and West along the Alamogordo Municipal line to the North Fork of Alamo Canyon Arroyo, thence Northwest 600ft along the North Fork of the Alamo Canyon Arroyo to an unnamed road, thence northwest along the unnamed road to S. Florida Avenue, thence North along S. Florida Avenue to the point of origin.

PRECINCT 63 – DUNGAN FIRE STATION, ALAMOGORDO, NM

Beginning at the intersection of the Charlie Lee Memorial Relief Rte. and U.S. Highway 54/70, thence Southeast along U.S. 54/70 Highway, to 10th St., thence West along 10th St. to the Union Pacific railway, thence South along tracks to the Union Pacific railroad spur, thence West along the Union Pacific railway to the Red Arroyo, thence Northeast along the Red Arroyo to Mesa Verde Ranch Rd, thence East along Charlie Lee Memorial Relief Rte. to U.S. Highway 54/70 and a point of beginning.

PRECINCT 64 – BETHEL BAPTIST CHURCH, ALAMOGORDO, NM

Beginning at the intersection of Thunder Road and North Scenic Drive, thence North 200ft. along North Scenic Drive to an unnamed arroyo, thence West along arroyo to East Tenth Street, thence East 0.3mi along East Tenth Street to and unnamed arroyo, thence North and West along the unnamed arroyo to Comanche Trl, thence north 20ft. to a fence line, thence West and North along the fence line to Thunder Road, thence West along Thunder Road to the point of origin.

PRECINCT 65 – OTERO COUNTY FAIRGROUNDS, ALAMOGORDO, NM

Beginning at the Intersection of Martin Blvd. and US Hwy 82, thence Southwest 3600ft. along US Hwy 82 to a powerline, thence East along the powerline to Dry Canyon Arroyo, thence Northeast along Dry Canyon Arroyo to N. Florida Avenue, thence North along N. Florida Avenue to N. Scenic Dr., thence West 2000ft. N. Scenic Dr. to an alley, thence North along the alley to the

Alamogordo Municipal line, thence West and north along the Alamogordo Municipal line to Goodyear Dr., thence West along Goodyear Dr. to Martin Blvd., thence Northwest along Martin Dr. to US Hwy 82 and the point of origin. .

PRECINCT 66 – CHAPARRL COMMUNITY CENTER, CHAPARRAL, NM

Beginning at the intersection of Salome Drive and Angelina Boulevard, thence West and South along Angelina Blvd to Luna Drive, thence West for .3mi to a powerline, thence North and Northeasterly along the powerline to Landing Strip Road, thence Southeast along Landing Strip Road to McGregor Range Road, thence Southeasterly along McGregor Range Road to US Hwy 54, thence Southwest along U.S. Highway 54 to the New Mexico - Texas state line, to the point of beginning.

The designated polling places shall be one of the following Voting Convenience Centers: Sgt. Willie Estrada Memorial Civic Center, Tays Special Events Center, Otero County Fairgrounds, Tularosa Public Safety Facility Court Room, Chaparral Community Center, La Luz Elementary School, Mescalero Community Center, Cludcroft Council Chambers, James Canyon Fire Station, Mayhill Community Center, Weed Fire Station, Pinon Fire Station, Timberon Lodge, Boles Acres Fire Station, Burro Flats Fire Station and High Rolls Fire Station.

(8) be in a location that is accessible and compliant with the requirements of the federal Americans with Disabilities Act of 1990.

D. As a prerequisite to consolidation, the authorizing resolution must find that consolidation will make voting more convenient and accessible to voters of the consolidated precinct and will not result in delays for voters in the voting process and that the voter convenience center will be centrally located within the consolidated precinct. The board of county commissioners shall give due consideration to input received from any local public body in the county regarding the location of voter convenience centers.

1-3-5. Precincts; powers of county commissioners.

A. The board of county commissioners shall by resolution:

- (1) create additional precincts to meet the requirements of Section 1-3-1 NMSA 1978; and
- (2) divide, abolish, combine or adjust the boundaries of any precincts as necessary to meet legal and constitutional requirements for redistricting.

B. Any necessary precinct boundary adjustments shall be submitted to the secretary of state no later than the first Monday in December of each odd-numbered year to become effective January 1 next succeeding the approval of the boundary adjustment. No precinct shall be created, divided, abolished or combined or the boundaries adjusted less than four months prior to a statewide election, except by order of the district court.

C. The county clerk shall notify the secretary of state in writing of any proposed changes in precincts or the designation of polling places made by the board of county commissioners and shall furnish the current geographical boundaries, designation and word description of each new polling place and each new or changed precinct.

D. The secretary of state shall review all new or changed precinct maps submitted pursuant to this section for compliance under the Precinct Boundary Adjustment Act [1-3-10 through 1-3-14 NMSA 1978] and Section 1-3-1 NMSA 1978.

E. Precincts shall be designated solely by whole numbers.

1-3-6. Precincts; boundaries; protest.

A. Any twenty-five or more voters of a precinct dissatisfied with the boundaries fixed for a precinct or location of the polling place designated by the board of county commissioners for that precinct may, within one hundred eighty days from the date a change to the boundaries of a precinct was approved in the case of a protest to the boundaries of a precinct, or at any time not less than one hundred twenty days prior to any statewide election, petition the district court of that county, setting forth the facts and reasons for their dissatisfaction and requesting that the board of county commissioners be required by mandamus to change the boundaries or polling place as set forth in the petition.
