**RESOLUTION NO. 02-12-19/107-10**

**RE: 2019 Compliance with the Planning Commission New Mexico Open Meetings Act**

**WHEREAS**, the Otero County Planning Commission (hereinafter referred to as "Commission") share the common belief that the democratic ideal is best served by a well-informed public; and

**WHEREAS**, the Commission is of the unanimous opinion that its business should be conducted in full public view; that their actions should be taken openly, and that their deliberations should be subject to public scrutiny; and

**WHEREAS**, the New Mexico Open Meetings Act, Sections 10-15-1 through 10-15-4 requires the Commission to conduct the business of the County by vote, and to form public policy in public meetings held after reasonable notice is given to the public of such meetings, as determined on an annual basis by the County Commission;

**NOW THEREFORE, BE IT RESOLVED**, by the Commission that:

1. Regular meetings of the Commission shall be held pursuant to the schedule attached hereto as "Exhibit A" and incorporated herein by reference. In the event circumstances require the rescheduling of a regular meeting of the Commission, notice of such rescheduled meeting shall be given as hereinafter provided.

Notices of these regular meetings shall be given once a month, not less than five (5) days prior to the first meeting in each month. The five (5) day period shall begin to run upon the delivery of notice to the media.

A proposed agenda will be available during the week before the meeting and may be obtained at the east entrance lobby at 1101 New York Avenue. The Commission, in accordance with law, will not take action on any item not included on the Agenda unless such business constitutes an emergency in accordance with the Open Meetings Act.

From time to time, the Commission may schedule its meetings in the various communities and regions of the County in order to serve specific local concerns or interests. In such events, the Commission will endeavor to provide accommodation to persons who may have to travel longer distances to have their matters heard by the Commission.

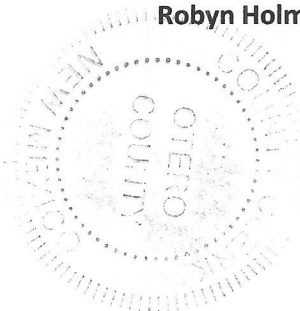

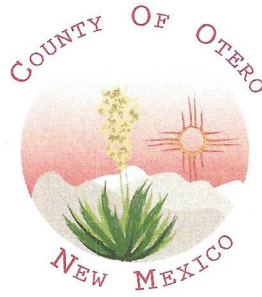
