## **Local Election Proclamation**

Pursuant to the Regular Local Election Act, NMSA 1978, Sections 1-22-2 to 1-22-19 (1969, as amended through 2019), I Robyn Holmes, County Clerk of Otero County, New Mexico, by virtue of the Authority vested in me, do hereby issue the following **PROCLAMATION**:

That a Regular Local Election shall be a nonpartisan election, and the names of all candidates shall be listed on the ballot with no party or slate designation.

That a Local Election be, and the same is hereby, called to be held throughout the County of Otero, State of New Mexico, and in each precinct thereof, on Tuesday, November 5, 2019 between the hours of seven o'clock a.m. and seven o'clock p.m.

That a voter may request an absentee ballot by mail beginning October 8<sup>th</sup>, 2019. The last day to submit an absentee ballot application to the Otero County Clerk's Office is October 31<sup>st</sup>, 2019.

That a voter may cast an absentee ballot in person on a paper ballot for this Election at the Otero County Administration Office, on October 8<sup>th</sup> thru November 1<sup>st</sup>, 2019, Monday thru Friday, from 8:00 a.m. to 5:00 p.m. and on Saturday, November 2<sup>nd</sup>, from 10:00 a.m. to 6:00 p.m. and;

That absentee-early in-person voting will be held at the alternate site at the Otero County Fairgrounds on October 19<sup>th</sup> thru November 2<sup>nd</sup>, 2019, Tuesday thru Saturday, 10:00 a.m. to 6:00 p.m. and the Inn of the Mountain Gods on October 30<sup>th</sup> – November 1<sup>st</sup>, 2019, Wednesday thru Friday, 10:00 a.m. to 6:00 p.m. and may be done in person on a paper ballot.

That mobile voting in-person begins at the mobile sites on the following dates and locations: October 19<sup>th</sup> at the Tularosa Public Safety Facility, October 26<sup>th</sup> at the Cloudcroft Council Chambers and November 2<sup>nd</sup>, 2019, at the Chaparral Community Center, from 10:00 a.m. to 6:00 p.m.

Voter Registration closes October 8, 2019.

That a Regular Local Election shall be held to elect qualified persons to membership on a local governing body and, where applicable, to elect municipal officers for the following offices:
